CLEAR CREEK INDEPENDENT SCHOOL DISTRICT- PROPOSITION A

Ratifying the ad valorem tax rate of \$0.9746 per \$100 valuation in Clear Creek Independent School District for the current year, a rate that will result in an increase of -19.87 percent in maintenance and operations tax revenue for the District for the current year as compared to the preceding year, which is an additional \$-50,585,883.

THE ISSUANCE OF \$265,000,000 SCHOOL BUILDING BONDS BY CLEAR CREEK INDEPENDENT SCHOOL DISTRICT FOR THE DESIGN, CONSTRUCTION, ACQUISITION, REHABILITATION, RENOVATION, EXPANSION, IMPROVEMENT AND EQUIPMENT OF SCHOOL BUILDINGS IN THE DISTRICT, THE PURCHASE OF NECESSARY SITES FOR SCHOOL BUILDINGS AND NEW SCHOOL BUSES AND THE IMPOSITION OF TAXES SUFFICIENT TO PAY THE PRINCIPAL OF AND INTEREST ON THE BONDS.
